Concurrent with a 1-.25 reverse stock split of the ordinary shares of Marconi Corporation, the outstanding ADRs (MRCIY) have undergone a ratio change from 1 ADR representing 10 ordinary shares (1:10) to 1 ADRs representing 2 ordinary share (1:2).

The ratio change will be effective September 9, 2003 and should not result in a price adjustment to MRCIY.

Members are further advised that deliveries in settlement of contracts in the **OLD** securities, which were executed prior to the announcement that the securities had been deemed worthless, shall be evidenced by either a) the **OLD** security; or b) a *Letter of Indemnity* which shall grant the purchaser any rights and privileges which might accrue to the holders of the physical securities. Such deliveries shall operate to close-out the contract and shall be settled at the existing contract price pursuant to Uniform Practice Code Rule 11530.
