Members are advised that no shareholder shall be reversed below 100 shares. Upon surrender of existing certificates, shareholders will receive the following:

- The reverse split will not affect shareholders holding less than 100 shares.
- Shareholders holding 100 to 2,000 shares will receive 100 post split shares, regardless of amount held pre-split.
- Shareholders holding 2,001 shares or more will receive a share amount subject to the 1-20 reverse split calculation, fractional shares will be rounded up to the next whole share.
