Pursuant to the Plan of Liquidation, the above company made an additional payment of principal (\$20.1210) on July 23, 2004 to holders of record on April 18, 2002. The distribution will be quoted ex on July 26, 2004 with due bills redeemable on July 29, 2004.

Since the notes have been dealt in flat, members are advised that effective July 26, 2004, trades executed in the notes should be on a "**reduced principal basis**" of \$388.525167 in lieu of \$1,000 principal amount and "ex" the pay-down of \$20.121 per \$1,000 note. Comparisons and/or confirmations should be marked to indicate the reduction in principal.

Members are further advised that any future distributions will be paid to holders of record of April 18, 2002. Deliveries after the record date should be accompanied by duebills representing any future payments. Please note that any future distributions will be calculated on a reduced principal basis.

Members should take immediate steps to adjust their records and bookkeeping systems to reflect the reduction in principal.
